

Terms and Conditions of “2019 Bike spring” promotion

1. The organizer of the promotion “2019 Bike spring”, hereinafter referred to as “Promotion”, is Nextbike Polska S.A. with its registered seat in Warsaw, ul. Przasnyska 6b, 01-756 Warsaw, entered into the register of entrepreneurs of the District Court for the city of Warsaw in Warsaw, XII Economic Department of the National Court Register under the number 0000646950, NIP: 5261029614, REGON: 021336152, hereinafter referred to as „**Organizer**”.
2. The Organizer offers the service of using the system of Wrocław Urban Bike under the name “**System Wrocławskiego Roweru Miejskiego**”, hereinafter referred to as the “**Service**”.
3. The principles and conditions of the use of the Service are specified in the Terms of Service of the system of Wrocławski Rower Miejski „**WRM Term of Service**” available on the website www.wroclawskirower.pl.
4. The terms provided for in the hereby Terms and Conditions of Promotion in capital letters, however, not defined therein, have the meaning assigned to them within the WRM Terms of Service.
5. The purpose of Promotion is to encourage the use of Service.
6. The Promotion shall be in place solely from 23 March to 29 March of 2019.
7. Every User holding a Client Account and fulfilling the remaining conditions for the use of Service specified in the Terms of Service of the system of Wrocławski Rower Miejski, may take advantage of the Promotion. Furthermore, also the users of other compatible Nextbike systems may benefit from the Promotion, having accepted the WRM Terms of Service.
8. Promotion consists of offering by the Organizer, within the period indicated in clause 6 above, preferential conditions of using the Service for its Users.
 - 8.1. 60 minutes of free of charge Standard Bike Rental;
 - 8.2. Free of charge delivery and collection of non-standard Bikes under the following 5 dedicated stations (solely in the scope of a simultaneous delivery of non-standard Bike to the dedicated station and its collection from the dedicated station):
 - a) Plac Dominikański (Galeria Dominikańska),
 - b) Lotnicza/Na Ostatnim Groszu,
 - c) Powstańców Śląskich/ Hallera,
 - d) Rondo Reagana,
 - e) Żmigrodzka/ Broniewskiego.
9. Standard bike rental or non-standard bike rental in the period specified in clause 6 of the Terms and Conditions of Promotion shall be equivalent to participating in the Promotion.
10. Users may avail of the Promotion unlimited number of times in the period specified in clause 6 of the Terms and Conditions of Promotion.
11. Promotion remains without impact on other promotions and fees (i.e. Additional fees) which may potentially be due for the Organizer by Users, in accordance with the provisions of the Terms of Service of Wrocławski Rower Miejski system and the pricelists applied by the Organizer.
12. Once the Promotion ends, the Organizer shall apply a standard fee for the use of Service, as specified in WRM Terms of Service.

13. In the scope not regulated by the hereby Terms and Conditions of Promotion, the provisions of WRM Terms of Service shall apply.
